High Speed Two (HS2) is the high-speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

Amendment to works notice (additional day)

We will be diverting BT cables on Stoneleigh Road for future construction works to take place. To complete this work safely temporary traffic lights will be in place on Stoneleigh Road from **Monday 11 July 2022 to Friday 15 July 2022 and Monday 18 July.** The traffic lights will be operational 24 hours each day. See map below for location. Access to all properties will be maintained.

- Works are scheduled from 11 July to 15 July **and 18 July**
- Temporary traffic lights will be in place 24 hours a day while the works are carried out.
- Access to all properties will be maintained during these works.
