High Speed Two (HS2) is the new high speed railway for Britain.

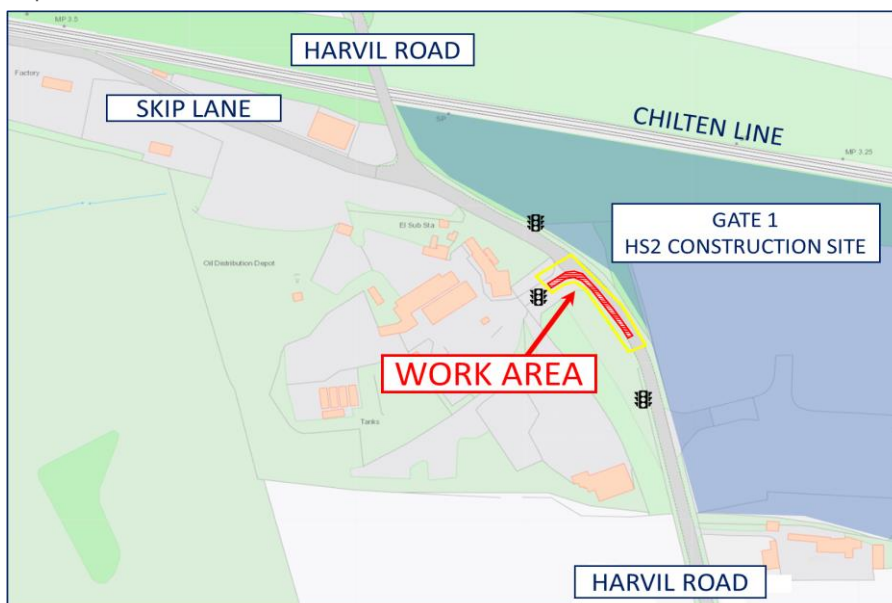

What we are doing

We wrote you recently to let you know that we would be carrying out remedial works on Harvil Road from the junction of Skip Lane, down to our Gate 1 site entrance gate. The works were due for completion 25 June between 8am and 1pm however, we need to extend the duration of the lane closure to allow us to relocate the fence line in the same area. These works will now take place between 8am and 5pm. The location of the work is shown on the map below:

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.
