High Speed Two (HS2) is the new high speed railway for Britain.



Drainage surveys planned on Canterbury Road

We recently wrote to you in early July 2022 about carrying out drainage surveys on Canterbury Road on the junction with Chichester Road. The works have been rescheduled and we will now take place overnight from 1 to 5 August 2022 between 8pm to 6am Monday to Friday.

The surveys will help us to understand the condition of the drainage system in the area and how best to protect them during the construction of the railway. We will investigate the manhole using a 3D camera scanner to capture internal dimensions and the condition of the sewer system. Once completed, we will replace the manhole cover.

We will have a temporary lane closure and traffic lights in place on Canterbury Road on junction with Chichester Road.
