High Speed Two (HS2) is the new high speed railway for Britain.

We continue to follow government guidance on reducing the spread of Covid-19. The health and safety of our workforce and the communities we work in is our priority. Please contact the Helpdesk if you have any questions relating to our response to the Covid-19 pandemic.

## Works planned on Oxford Road and Kilburn High Road

From 15 to 26 August 2022, we will be carrying out a series of ground investigations at the junction of Oxford Road with Kilburn High Road.

The ground investigations will consist of digging a temporary trench to confirm the location of utilities under the surface of the road. The investigations will help us to understand and aid the design of the new railway and the best ways to protect or divert any utilities during construction.

The ground investigations will take place between 8am to 6pm Monday to Friday and 8am to 1pm Saturdays, if required. We will use noise reducing barriers where possible to help minimise any noise disruption to the local community, working as efficiently as possible whilst keeping our work areas safe and tidy.

## How this might affect you

To ensure the safety of the public and our staff, temporary changes will be in place at the junction of Oxford Road with Kilburn High Road (shown on the following page).

A lane closure with two-way traffic lights will be in place on Kilburn High Road with a full road closure on the junction of Oxford Road with Kilburn High Road. A clearly signed diversion route for vehicles and pedestrians will be in place.

Your utility services will not be affected during these works.

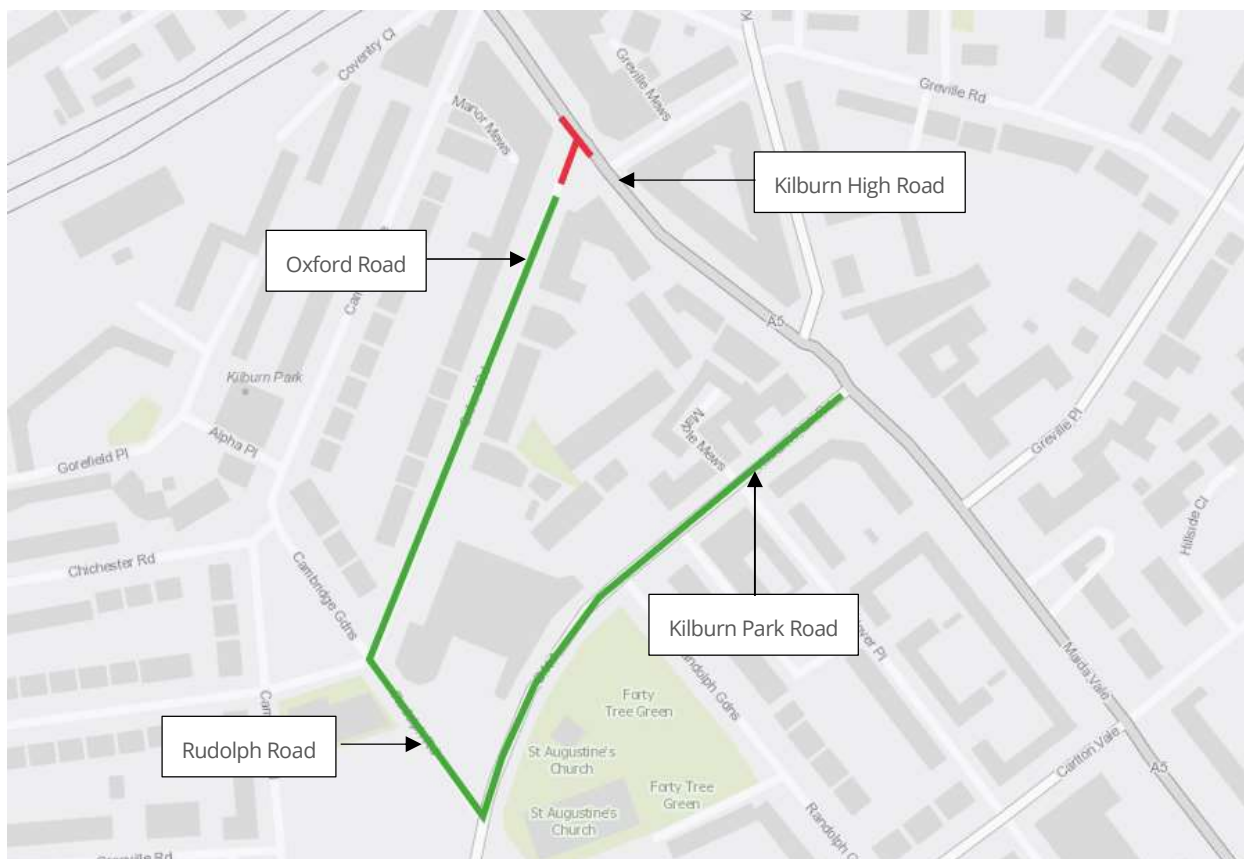


## Map showing the temporary changes on Oxford Road and Kilburn High Road

To help us maintain traffic flow on the road network, we have agreed the following diversion route:

Vehicles travelling west on Oxford Road will be diverted south onto Rudolph Road, east along Kilburn Park Road to join Kilburn High Road. Vehicles travelling south on Kilburn High Road will be diverted west along Kildurn Park Road and then north on Rudolph Road to join Oxford Road.

Access to businesses and homes will be available at all times.

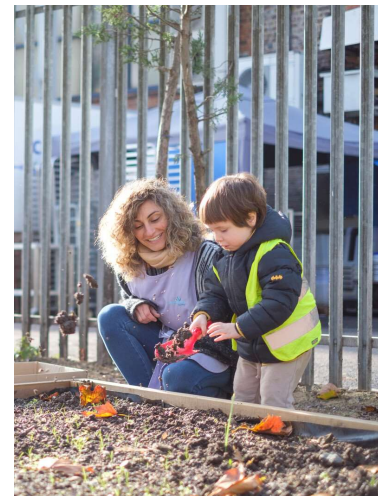
## About our Community and Business Funds
