

Notice of road closure, northbound A452 Chester Road between A446 and Northway Island

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work will we be doing

To build the new railway, the northbound A452 Chester Road between the A446 and the Northway Island is being significantly remodelled in a number of phases.

The first phase, subject to approval, is to close the A452 between the A446 and the Northway Island, this is to connect the new bridge over the A446 to the new interchange that has been constructed over the HS2 line.

A fully signed diversion will be in place, northbound traffic will be diverted up the A446 to the M6 Junction 4 roundabout and return southbound on the A446 to the Brownhills slip road and then onto the Northway Island. (Please see map over). On the approach to the road closure there will be short length of lane one closed.

When these works will take place

This road closure will be in place 24 hours a day seven days a week from **Monday 22 August to Friday 16 September**.

- Additional queuing traffic at the M6 J4 roundabout
- Significant construction activity on the A452

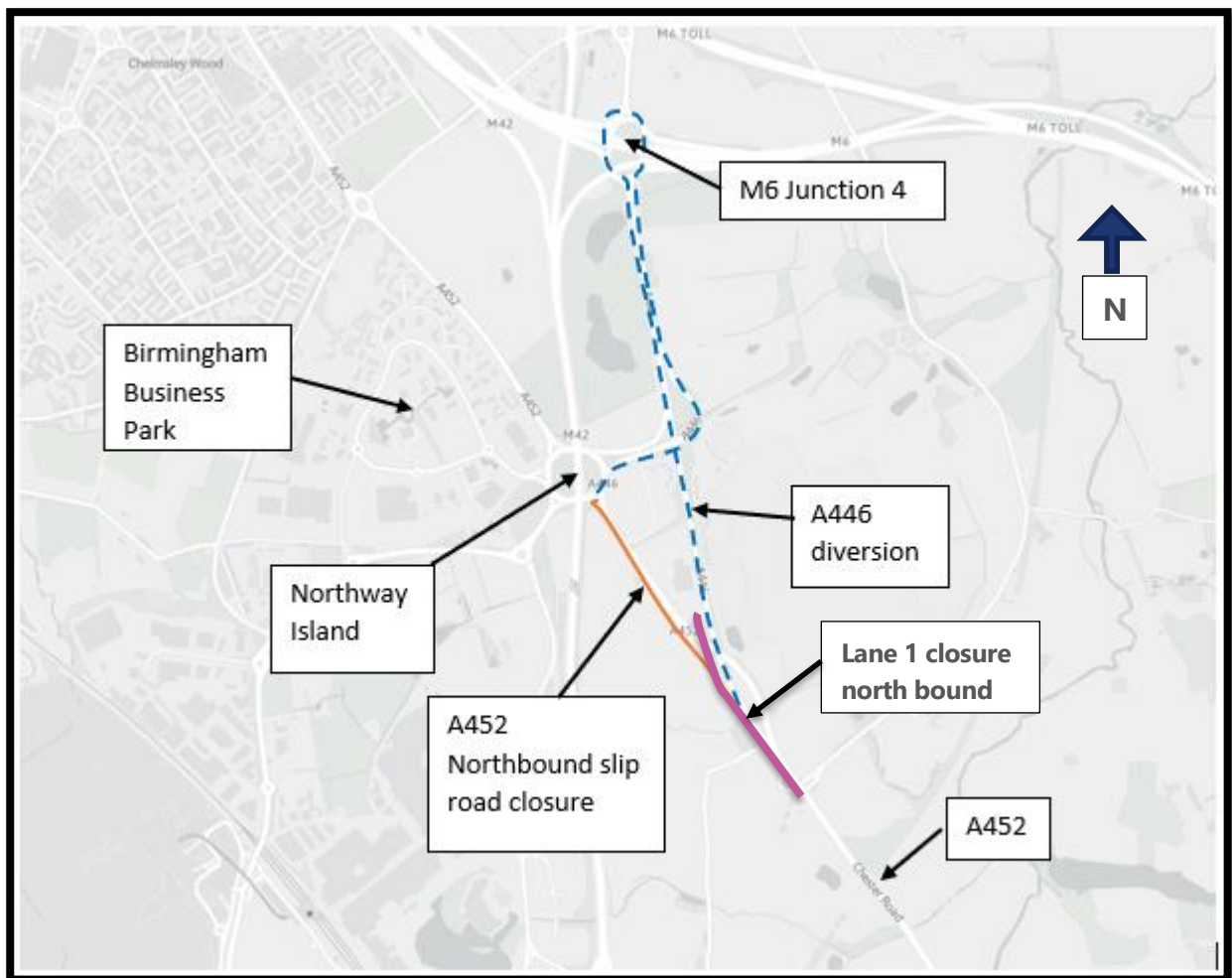
