Notice of extended working hours for a concrete pour at **Old Oak Common**

High Speed Two (HS2) is the new high speed railway for Britain. As we reintroduce face to face engagement, which is in addition to the ongoing virtual engagement, we will continue to follow government guidance on reducing the spread of Covid-19. Extended working hours for concrete pour

On 5 August, we will be completing a single concrete pour so that we can construct the propping beams and slabs in the West Box. The beams will give the underground station box overall structural support and the slabs will form the roof of the station box, both integral parts of the design. Please see the map overleaf for the location of these works.

For safety reasons a concrete pour must be completed in one session. If stopped for any length of time and then restarted, a cold joint can occur within the concrete causing the column to weaken. This is not achievable within the current working hours and therefore requires longer working hours to complete the pour successfully. On the day of the concrete pour, working hours will be between 8:00am - 8:00pm. The pour will also require additional supporting vehicles to be on site.

Noise and dust

This activity is not noisy, and we do not expect it to disturb the community. However, additional acoustic blankets will be placed around the activity. Vehicles and personnel will enter and exit site quietly to avoid unnecessary noise around the local area. We will continually monitor noise and dust levels throughout the works.

On 5 August, the specific day of the concrete pour, our working hours will be between 8am and 8pm, however all other works will take place in normal working hours, Monday -Friday 8am - 6pm and Saturday 8am - 1pm.

An increase in construction traffic on Old Oak Common Lane site entrance during this week.

What we will do

We will use best practicable means to minimise any disruption by increasing the number of traffic marshals at the Old Oak Common entrance. We will also be monitoring all noise and dust levels.
