High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To complete vegetation works safely, we will be closing one lane on Dalehouse Lane between Whitehead Drive and the entrance to Dalehouse Farm. (Please see map below).

When these works will take place

These works will take place from **Monday 15 August to Friday 19 August, between 9.30am and 3.30pm**. The lane closure will be controlled by two-way temporary traffic lights. The road will be reopened outside of these hours.

Our workforce may be on site one hour before and one hour after to set up and secure our equipment.

Off peak lane closure on Dalehouse Lane from **15 August to 19 August 2022** between **9.30am and 3pm**.

One lane closure in place controlled by temporary **traffic lights in operation**.
