Notice for temporary traffic management on Dalehouse Lane for emergency vegetation clearance

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be completing

Urgent works are required to clear vegetation for reasons of safety, due to visibility issues. To complete these works safely we need to install two-way temporary traffic lights in Dalehouse Lane on Friday 8 July. The lights will be in place between 9.30am and 3.30pm. Our workforce may be on site one before and one hour after to set up and secure our equipment.

Whilst the temporary traffic lights are in operation, the plant crossing on Dalehouse Lane will be stood down. Once the emergency works are complete the plant crossing will be in operation once more.

Access to property will not be affected.

HS2 during the Coronavirus pandemic


