**Community engagement at a glance (March - May 2022)** 

Since we last met....

We have engaged with 521 people at engagement meetings.

We have had 3,342 visitors to the HS2 in Camden website with 525 subscribers to news updates.

In total £1.3m has been awarded to 12 local projects in Camden through CEF and BLEF.

## **Engagement Events**

#### Adelaide Road

- 16 March, 20 April, 18 April virtual 1:1 sessions held for residents local to Adelaide Road.
   Residents are able to book a 20-minute slot, sessions are held months on Wednesday afternoon-evenings. Attendance: 0 attendees in March, 2 attendees April, 2 attendees May.
- 21 March Adelaide Road walkaround SCS Community & Stakeholder Engagement colleagues met with newly appointed LB Camden HS2 Support Worker.
- 23 March Camden Tree Panel met to discuss vegetation pruning on boundary of Adelaide Road Vent Shaft site.
- Two face-to-face resident 1:1 meetings were held 14 & 21 April, attended by SCS
   Community Engagement Manager and an Engineer from the Adelaide Road vent shaft site.

   The 1:1's were scheduled following enquiries to the HS2 Helpdesk regarding future ground anchor installation.
- Adelaide Road Community update event held 20 May, 3 7pm at St. Saviour's Church, Eton Villas; to provide an update on current and upcoming works. There were 18 attendees from the local community; key topics of interest were Ground Anchor installation works, Noise Insulation and the summer utility works.

 SCS JV have liaised with Veolia and LB Camden to support with waste collection and ensure there are safe stopping points for the Veolia collection vehicles. SCS JV subcontractor Hatton's assist weekly collections by holding red signals to allow safe stoppage between 68-78 Adelaide Road and have a dedicated refuge bay adjacent to Beaumont Walk, Adelaide Road.

#### Euston Approach and Camden Cutting

o In total 8 virtual and 16 face-to-face engagement events have been held in the Euston Approaches with 25 people attended.





- Weekly pop-up events were held every Wednesdays on Stanhope Parade and Mornington Street Bridge/Mornington Terrace; drop-in events took place in Surma Community Centre on 31 March and 24 May.
- Community pop-up key themes:
  - o Positives: Resident commented on frequency of ANL updates extremely beneficial
  - o Concerns: Lorry routes, traffic management and impact on parking



   on 24 May with 65 attendees.
- Engagement event at the Euston Station piazza on 7 June. Over 100 conversations have been held.

- Weekly site walks and one-to-one meetings along with the regular meetings with Drummond Street traders (24 March, 26 May), Stephenson Way Group (31 March, 26 May) and University College London (30 March, 25 May) were held to update on progress of works in the west and south of the Euston Station. A number of ground investigations, utility surveys and utility works planned for spring 2022 both the north and south of the station were discussed during these meetings.
- Ongoing engagement is being carried out with a number of businesses, organisations and institutions on the north and south of Euston Road regarding potential ground movement and potential mitigations required due to HS2 works.
- MDJV hosted four community engagement events:
  - Two drop-in surgeries on the 7th and 9th March to discuss utility works north of the station – 12 people attended in total.
  - Two engagement sessions with the Maria Fidelis Constructing Steering Group on the 21<sup>st</sup> March and 16<sup>th</sup> May to provide an overview and progress on the works to new Construction Skills Centre and site accommodation building – 10 people attended.
- Further improvements had been introduced in April to the commuters at the Euston station:
  - o Drummond Street arch have been installed on the walkway connecting with the station.

## **Communications**

 As part of a regular Camden-wide updates, newsletters, and a three-monthly construction lookahead have been distributed. These updates detail upcoming works, engagement, and community investment. The next update is scheduled for early June.

# **Community investment, School Engagement, Employement and Education**

#### School engagement / Work experience

MDJV and SCSJV hosted a school site visit by 10 Year 10 students from Hampstead School.
 In March the students visited the Maria Fidelis, Traction Substation and Euston Approaches worksites and met with apprentices on the project.



 Two Year 12 students from Acland Burghley and three students from City and Islington College attended on MDjv worksite for a week's work experience learning about all aspects of the project, meeting project managers, senior leaders and apprentices.

### • Apprenticeship:

- MDJV apprentices attended school assemblies for Year 10 and Year 12 at the UCL Academy ahead of planned site visits taking place in June and work experience in July. Apprentices on the project spoke to students about their experience and the benefits of working at HS2 Euston.
- Local apprentice recruitment process was launched for four MDJV roles targeting Camden residents



 Apprenticeship Celebration - Camden resident Leon Line was announced as the **900th** Apprentice on HS2 project.

24-year-old Leon joined MDjv after being made redundant from his job as an electrical engineering apprentice during the pandemic.

The King's Cross Construction Skills Centre supported Leon with his application and helped him to prepare for his interview, enabling him to secure a two-year Level Three Civil Engineering apprenticeship with Mace Dragados.

#### Local recruitment

 Representatives from HS2 Ltd, Mace Dragados and SCS Railways attended the Camden Jobs and Skills Event at the Camden House LABS Triangle on 19<sup>th</sup> May. Over 400 people registered to attend and were able to hear about, and express an interest in, the latest job and apprenticeship opportunities available across the HS2 programme in London.



- Supporting charities and volunteering:
  - Castlehaven Community Centre 'Edible Garden' in Camden has been transformed, thanks to the team at SCS|V Victoria Road Crossover Box.

The garden is used to grow food for the local food bank as well as provide an area for educational workshops and therapeutic sessions. The work created new planter boxes, additional shingle, an irrigation system and even a 'bug hotel' made from a fallen ash tree damaged by Storm Franklin at our Adelaide Road site.



Carmen Moore, Castlehaven Community Association Operations Manager, shared a feedback from local community: "Thank you so much...This is amazing! It would have taken us over six weeks and £5,000 worth of funding to get done what the SCS team completed in only a few hours."

• **Camden Town Shed** – Recently HS2 CEF funding have been successfully approved to support this mental health charity combating isolation providing wood/craft workshop and supervised vulnerable adults' classes.



SCSjv continue to support Camden Town Shed; in March the team provided timber for workshops and 30x Perspex screens that the shed is using to install across their three balconies; On 4 April meeting was organised with **West London College** to discuss the development of the website and social media project for Camden Town Shed.

• Euston Foodbank move - relocation to Phoenix Road. In April, SCSjv along with support from MDJV successfully facilitated the foodbank with their move from Lancing Street to the old St Aloysius school on Phoenix Road, a bigger site for them to operate in given the increasing demand on their services. The required several operatives and a flat-bed van across two half days of work, lifting and shuttling supplies.



- Wellcome Collection MDjv provided materials for a commission for the Rooted Being exhibition - Resolve Collective with Coram's Fields Youth Club.
- From early March every third Tuesdays, SCSjv volunteers are holding litter pick up days in the Regents Park Estate. To date the team organised 5 litter pick up days, 37 volunteers attended, 46 bags of litter picked up, total weight - 113.5kg.



 Regents Park Children's Centre – meeting held with the nursery on 31 March followed with the supply of materials such as traffic cones, signs, shingles to set up a construction area in the playground in May.

- The HS2 Jobs Board helps people the find the latest vacancies across the project and allows prospective candidates to search for vacancies by region, or by specialism, allowing them to quickly identify opportunities that match their criteria.

## **Working groups**

The ECRG working groups covering noise insulation, traffic, air quality and trees, and design development are an opportunity for complex technical topics to be discussed in detail outside of the main ECRG meeting and for suggestions and proposals from the community to be considered. Below is a summary of topics covered recently.

#### Noise Insulation Working Group (NIWG)

 NIWG meeting took place on 26 May. The meeting had been cancelled as no community representative joined the meeting. The team agreed to set up a face-to-face meeting with Ampthil Estate representative.

#### Traffic Working Group (TWG)

- o Meetings held on 14 March, 11 April and 9 May
- Key points at the meetings:
  - Update and coordination from MDJV, SCS, UK Power Network and Thames Water of upcoming works. Actual and forecast LGV figures were presented.
  - TWG meeting format change from April onwards. Meeting time reduced to an hour with site visit (if required) scheduled later in the week. TLG slides will be circulated 3 days in advance and at the meeting each contractor will provide a summary highlighting new works or changes to previous works.
  - Meeting took place on 27/04 with SCS/TfL and CTWG members to discuss upcoming
    utility works on Lidlington Plan and Harrington Square. Good discussions took place on
    site to give overview of works and highlight community concerns including access to
    property and possible congestion during works
  - SCSjv installed right-hand turn on Hampstead Road in May.
  - MDJV completed new footway on Hampstead Road.
  - Update on the ongoing utility connection works to SCS worksites and works on Hampstead Road, Lidlington Place and Varndell Street
  - Design for utility works on Parkway are due end May.
  - 16 replacement bays provided for the 14 parking bays suspended on Park Village East for the lorry lay-by.


#### Air Quality and Trees

- Meeting held on 3 May.
- Key areas discussed:
  - No Net Loss of Biodiversity. Presentation by MDjv to achieve no net loss in Euston area, the calculations presented are an interim point in time assessment and will be recalculated as the design progresses.
  - Air Quality Update. The group noted the previously circulated slides on Compliance, monitoring & innovation.   - Construction Carbon Emissions. A slide presented on temporary power sources using LPG. The technology made use of redundant fossil fuel engines which have been converted and it is planned that this will include the use of hydrogen in the future. Whilst the main plan was to get machinery onto mains power where possible this solution was more sustainable than conventional generators and could be scaled up if needed.
  - Material by Rail. Not currently possible to provide a firm update on the position with
    materials by rail. The main change since this topic had been discussed with the Air
    Quality group previously was the integration of the designs of the HS2 and Network
    Rail conventional stations and the reduction in platforms for the HS2 facility allowing it
    to be built in one phase. Originally the area reserved for the second phase of platforms
    was planned as the area to accommodate materials by rail. The group members could
    make their views known to LB Camden through their ward councillor or council officers


## **Complaints and Enquiries**


