High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci (BBV) is working on behalf of HS2 Ltd to build the new railway in your area.

Planned works along B4118 Birmingham Road, Water Orton

Temporary four-way traffic lights are planned to be in operation 24 hours each day, all week, including at weekends, along a section of B4118 Birmingham Road, Water Orton, from Monday 22 August 2022 extended to Friday 9 September 2022.

This is to allow us to install a specialist utility duct required for the tunnel boring machine (TBM).

Please note these dates are indicative and are subject to change at short notice.

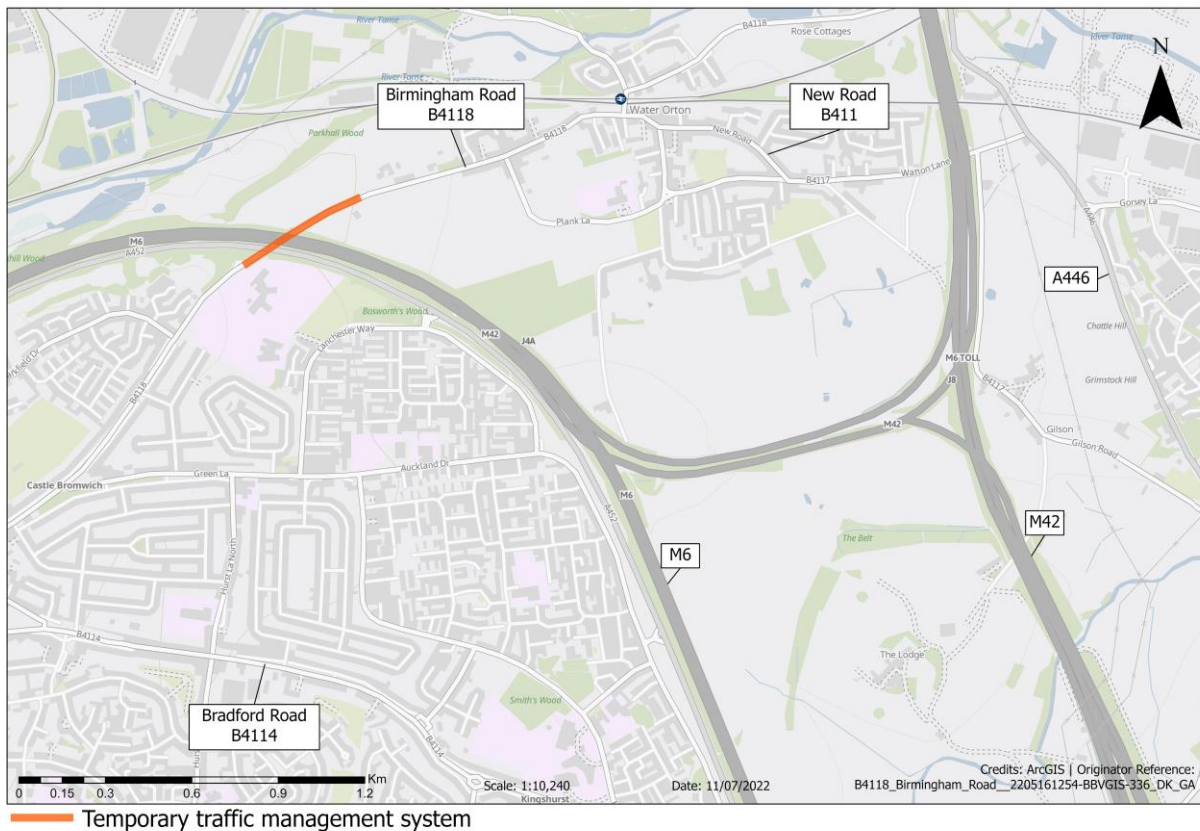
