High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci is working on behalf of HS2 Ltd to build the new railway in your area.

When, where and why the need for Ground Investigation works

We intend on carrying out a series of ground investigation works within sections of Bromford in Birmingham, as shown overleaf.

We plan to undertake these works from Monday 1 August 2022 for up to a maximum period of 12 weeks. These non-intrusive works will be undertaken during weekdays only, from 8:00am until 5:00pm.

These works will enable us to locate third party utilities as well as investigate ground conditions ahead of the launch of the tunnel boring machine (TBM) which is planned for Summer 2023.

Pedestrian access will be maintained.

HS2 during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance.

We will be monitoring noise levels at all times.
