

# Notice of overnight closures on B4455 Fosse Way in Offchurch


High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are underway in your area, carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

This notification is to inform of overnight closures required along the Fosse Way from 8pm to 6am on Wednesday 13 and Thursday 14 July. The Fosse Way will be closed from the A425 to Long Itchington Road and Welsh Road will also be closed from Long Itchington Road and Bascote Road as part of these works. Long Itchington Road (west of the Fosse Way) will be re-open between 11 to 18 July for local diversions.

Access for local residents, businesses and cyclists using the National Cycle Route 41 will be maintained. Temporary traffic lights will continue to be erected for the Fosse Way highway scheme as and when required until we fully complete works.
