



Notice of overnight lane closures on the M42 motorway between junctions 9 and 10

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We will be undertaking surveys along a section of the M42 between junctions 9 and 10. To undertake our works safely, we will work with National Highways (subject to consents) to:

- Close a lane on both the M42 southbound and northbound, on Friday 29 July to Saturday 30 July 2022. We will install traffic management from midnight and remove it by 6.00am the following morning.
- Minimise the impact on road users by keeping one lane, of both the Southbound and Northbound, open at all times over this period.

These works are part of the wider HS2 works in the area as we start to prepare for the bridge which will cross the M42 in this location, expected in winter 2022.

HS2 during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance.

The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

Duration of works

We will close a lane of both the Southbound and Northbound M42, between Junctions 9 and 10 on 29 July to 30 July 2022 from midnight to 6.00am.

What to expect

We will have clear signage in place to inform road users of the lane closures.

Our vehicles will access these works from junction 9 of the M42 Motorway.

Some low levels of noise from these works.

What we will do

Inform you in advance of any changes to the dates shown.

Keep all sites safe and secure.

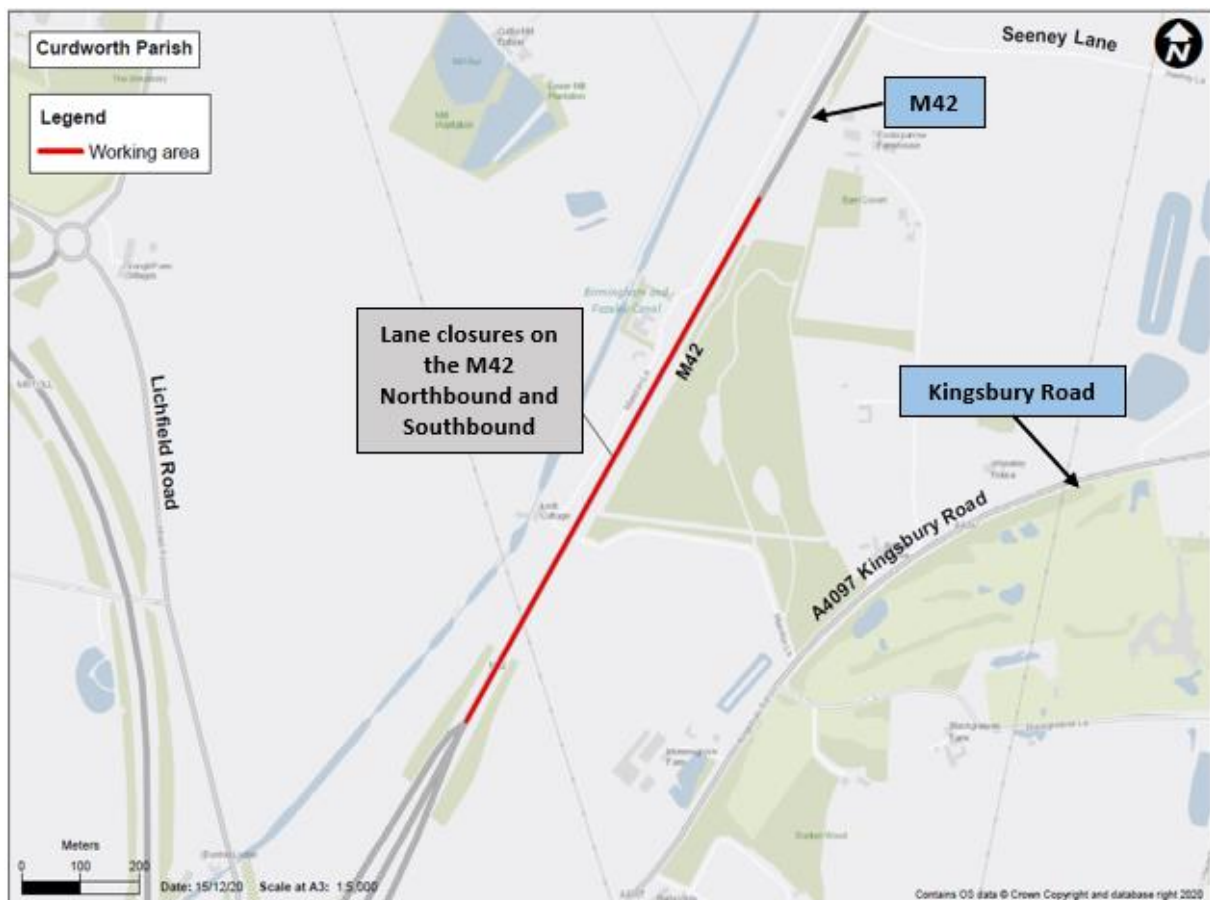
