Footpath reopening along Old Oak Common Lane

Following the completion of works to the boundary wall and hoarding installation, we are now in the position to reopen the footpath along Old Oak Common Lane.

To be able to do this work safely and in times of low traffic, the team will be removing the barriers this evening (12 July) between 7pm and 10pm.

You may notice some of the team removing the barriers and sweeping the pavement.

The barriers will be removed between 7pm and 10pm on 12 July.
