High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. The health and safety of our workforce and the communities we work within is our priority. You can sign up for regular updates in your local area at www.hs2inbucksandox.co.uk.

What are we doing?

In July, we will be carrying out topographical surveys on Barton Hartshorn Road, also known as Stratton Audley Road. Topographical surveys will help us to finalise the design of the new railway and road alignments and where possible allow us to reinstate features after construction.

These surveys are part of our preparatory works for the School End bridge. Once completed, this bridge will carry traffic over the HS2 rail line.

In order to carry out these surveys safely and effectively, we will need to put in place a daytime road closure with signed diversion. This is required because our staff will be working directly on the carriageway.

When will these works take place?

Barton Hartshorn Road will be fully closed, from 8.00am to 6.00pm on Thursday 21 July 2022, with a local diversion route in place.

We will work to reopen the roads as soon as possible, to reduce disruption.

Works will commence Thursday 21 July 2022 for one day.

Normal working hours:

Monday to Friday

8.00am – 6.00pm

Saturdays

8.00am – 1.00pm

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

What to expect

Daytime road closure and some additional traffic for topographical surveys.

Noise from plant and equipment used for the works.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.
