High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. What are we doing?

As part of our preparatory works for the future diversion of a local water mains, we will be carrying out Ground Investigation (GI) works along Church Lane in Mixbury.

Our GI works will involve surveys and trial holes. These activities will allow us to accurately identify the location and condition of the existing water mains that will be diverted while we build HS2.

As we will be conducting these surveys and trial holes very close to the local highway, we will need to close a small section of Church Lane for one day in July.

When will these works take place?

A section of Church Lane will be fully closed from 8.00am to 6.00pm on Monday 25 July 2022.

Duration of works

Works will commence on Monday 25 July 2022 for one day.

Core working hours:
Monday to Friday
8.00am – 6.00pm

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

Temporary road closures and some additional traffic.

Varied activities with both quiet and busier periods.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

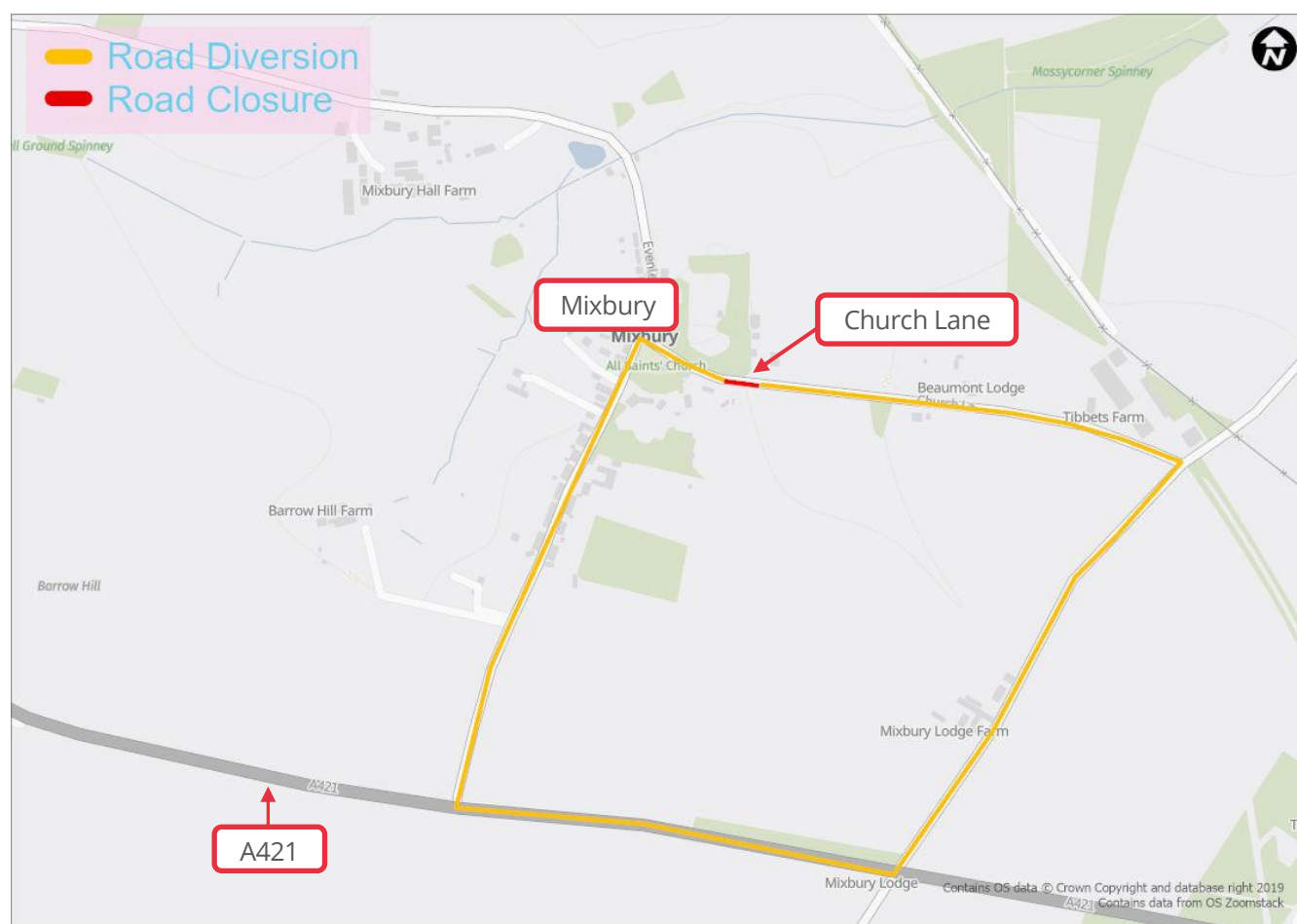
