What we are doing

From 5 to 16 August 2022, we will be carrying out the construction of the vehicle entrance along Harvil Road.

These activities will include excavation works and the relocation of BT broadband cables. The location of the work is shown on the map below.

In order to carry out these works safely, a lane closure will be in place for the duration of these works between our Gate 1 site compound south of the Chiltern Line and Shorthill Cottage.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way.

We will ensure that disruption is kept to a minimum.
