



## Notice of traffic management on Gilson Road (revised dates)

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

### The work we will be completing

BBV were set to complete drainage surveys on Monday 20 June and Tuesday 21 June. Unfortunately, these works were delayed. We will now complete drainage survey works in areas of Gilson Road on Monday 18 July and Tuesday 19 July.

In order for us to carry out works safely, we will implement a two-way traffic light system on Gilson Road during this period. These traffic lights will be used in a rolling system, completing 150 metre sections at a time. There may also be short durations of three-way traffic lights where Gilson Road meets Watton Lane.

**The traffic management will be in place from 9.30am until 3.30pm each day. The location of traffic management is outlined on the map on page 2.**

### COVID-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

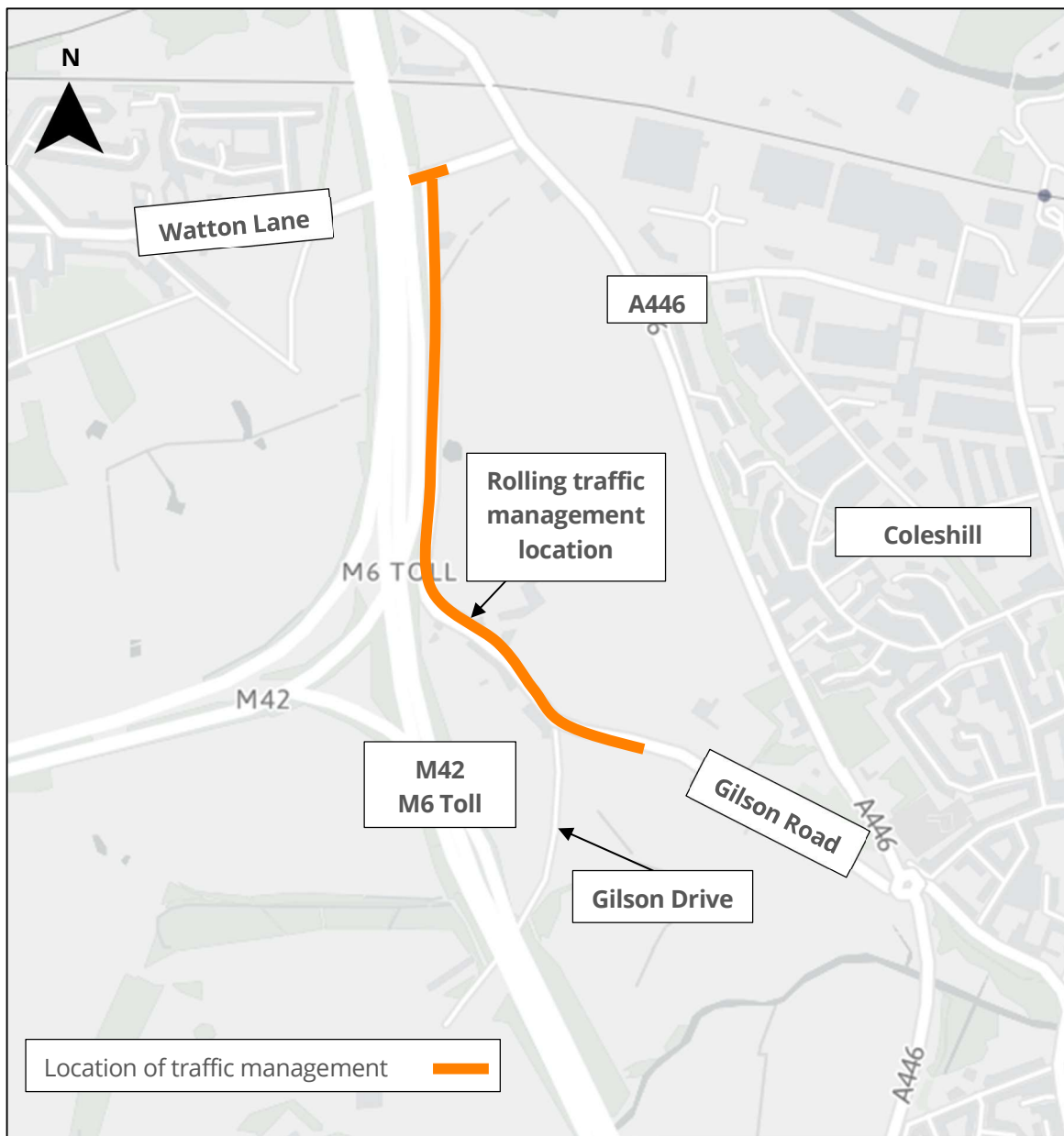
