High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we are doing

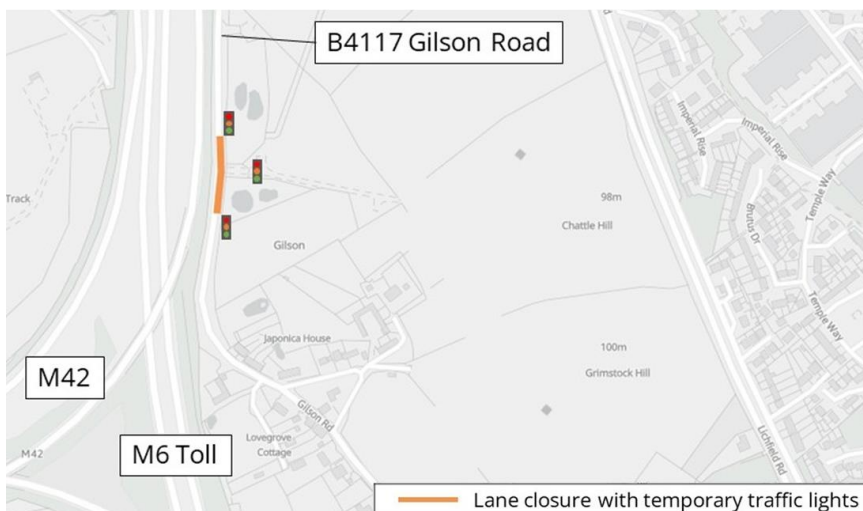
We will be removing vegetation along sections of Gilson Road in August to ensure the safety of road users and our workforce, whilst we construct the HS2 railway.

We'll be starting work on Monday 1 August

To carry out this work safely, we'll install three-way temporary traffic lights on a short section of Gilson Road near our site access, from **Monday 1 August for two days.**

Our working hours will be 9.30am to 3.30pm each day. Our workforce may be on site up to an hour before and after those times to set up and close down the site.
