What we are doing

We wrote to you earlier this month to update you on the preparation of the access road in front of the site office. The link to the original notification can be found here: [Community notice July 2022](#)

We need to continue with these works following test taken on the ground in this area.

From 25 July to 5 August 2022, we will continue to prepare the access road in front of the site office. Some excavating and compacting of the area will be required.

On **Saturday 13 August 2022**, we will be installing a layer of tarmac on the access road at the front of the site office as well as the lower platform down at railway level.

You may smell the tarmac being laid during this time.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.
