### What we are doing

We wrote to you in May, to update you on the installation of the pipeline from our site at South Ruislip to Yeading Brook. The link to this notification can be found here: [Yeading Brook pipeline install](#)

We are continuing with these works and from 4 July to 26 August 2022, we will be installing pipework along the railway embankment from Bridgwater Road to Yeading Brook.

Work will be carried out during core working hours, Monday to Friday 8am – 6pm, however there may be periods when installation will be undertaken at night as required by Network Rail.
