Footway closure on Prince Albert Road – 15 to 19 August

High Speed Two (HS2) is the new high speed railway for Britain.

Site maintenance at the Vehicle Holding Area

Over the next few months, we will carry out a range of site maintenance at the Vehicle Holding Area including removing some of the temporary welfare cabins and finishing works to the entrance.

Footway closed on Prince Albert Road – 15 to 19 August

From 15 August, we will close a section of the footway on Prince Albert Road, near the entrance to the Vehicle Holding Area to fix the footpath. We will divert pedestrians via the eastern footway.

There may be periods of increased noise as we breakout the footway, to remove and replace the tactile paving before pouring tarmac. We will use acoustic blankets to limit noise where possible.

We expect the works to take **about a week** to complete.

Extended hour working – Saturday 10 September

For safety, we will lift and remove the temporary cabins during the weekend when there are less people and vehicles on site. We will work Saturday 10 September, 8am to 5pm, to clear and disconnect the cabins before using a crane to lift them onto lorries. The crane will be delivered to site early Friday morning, and removed Saturday evening.

The main welfare building will remain as is. We don't expect these works to be noisy.
