High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. ## What are we doing?

Ahead of us completing the utility diversion works in Calvert, we need to carry out some remedial repairs to the footway on Brackley Lane and also to the carriageway near to the junction of Brackley Lane and Werner Terrace.

### Brackley Lane – three way temporary traffic lights

The footway works will commence on **Monday 25 to Tuesday 26 July 2022 (subject to local authority consents)**.

The three way traffic lights on Brackley Lane and the junction of Cotswolds Way will be operational from 08.30am to 4.30pm. Outside of these times the lights will be removed. Please see map enclosed

### Brackley Lane and junction Werner Terrace – road closure

Works will take place on **Wednesday 27 and Thursday 28 July 2022 (subject to local authority consents)**.

To undertake the repairs to the carriageway, we require the road to be closed from 08.30am to 4.30pm. Outside of these times, the road will be open as normal. Please see map enclosed.

Where the works are near to the frontage of a resident's driveway, access will be restricted during working hours, however we will provide access at the start and the end of the shift and speak directly to those affected.
