Network Rail overnight working on rail tracks

On Saturday 6th and Sunday 7th August, Network Rail will be carrying out overnight works during rail track possessions when trains are not using the tracks. At this time, we will be completing works to move a high voltage cable, in coordination with Network Rail. This will involve removing materials and a section of track at the base of the retaining wall, then moving the high voltage cable into this location.

Works will take place during the following hours:

Saturday 6th August **11pm to 12pm** Sunday 7th August

Sunday 7th August **8pm to 6am** Monday 8th August

No site activity will be taking place; however, the welfare units will be used by staff during these works for staff briefings and breaks.

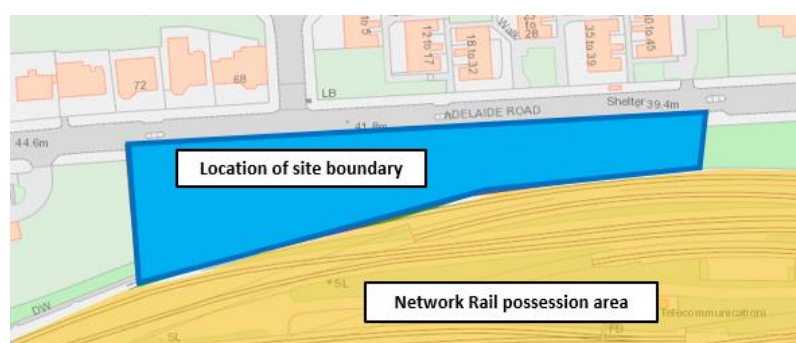
Additional Network Rail overnight works will take place on:
