# **Surveys planned near Perivale West Bus Garage**

On 30 August and 14 September between 8am – 6pm we will be carrying out utility surveys to help us understand the condition of the drainage system in the area and how best to protect it during construction of the railway. We will investigate the condition of the sewer system accessing a number of manhole covers using a camera and we may need to flush the system if any blockages are found.

In order to gain access to the manhole covers, we will need to carry out some low level vegetation works. Our operatives will use handheld power tools to cut back vegetation blocking access to the manholes. You may also notice some noise from the tanker jet wash which will be on standby should we need to clear any blockages.

We will monitor our working methods throughout these works to ensure any disruption is kept to a minimum Your utility services will not be affected during these works.
