The work we will be completing

We will be diverting power cables on the A429 Coventry Road between Kenilworth and Coventry. This is required in preparation for the future bridge structure and site access on the A429 in this location.

Work will take place on the following dates:

Monday 12 September to Friday 19 September 2022 between **8am** and **6pm**. Temporary traffic lights will be in operation 24 hours per day on these dates.

To carry out this work safely, our contractor will require temporary traffic lights and will use vacuum excavation.

Location

This work will be taking place outside of the BBV HS2 site on the A429 Coventry Road, Kenilworth. See map below for exact location.

Low levels of noise from the work we are completing.
