High Speed Two (HS2) is the new high speed railway for Britain.

We continue to follow government guidance on reducing the spread of Covid-19. The health and safety of our workforce and the communities we work in is our priority. Please contact the Helpdesk if you have any questions relating to our response to the Covid-19 pandemic.

Works planned on Loudoun Road and Alexandra Road

From 30 August to 9 September 2022, we will be carrying out a series of ground investigations on Alexandra Road.

The ground investigations will consist of digging a temporary trench to confirm the location of utilities under the surface of the road and grass verge. The investigations will help us to understand and aid the design of the new railway and the best ways to protect or divert any utilities during construction.

The ground investigations will take place between 8am to 6pm Monday to Friday and 8am to 1pm Saturdays, if required. We will use noise reducing barriers where possible to help minimise any noise disruption to the local community, working as efficiently as possible whilst keeping our work areas safe and tidy.

How this might affect you

To ensure the safety of the public and our staff, temporary changes will be in place on Alexandra Road (shown on the following page).

A single lane closure will be in place with two-way traffic lights on Alexandra Road along with a footpath closure. A clearly singed diversion route for pedestrians will be in place.

Your utility services will not be affected during these works.
