



# Notice of temporary traffic management in Coventry Road, Cubbington

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## Traffic management update

To help facilitate the building of HS2, we need to construct a farm access and drainage crossing in Coventry Road, Cubbington.

To complete this work safely a road closure is required and will be in place for five days.

The road will be closed between **8am and 6pm** from **Monday 15 August 2022** to **Friday 19 August 2022**.

A full diversion will be in place throughout the closure.

**The closure and diversion will be suspended overnight, and two-way temporary traffic lights will operate during this time.**

There will be no weekend working. Access to properties will be maintained throughout. Our workforce may be on-site one hour before and one hour after to set up and secure our equipment.

## HS2 during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with coronavirus.

The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance.

The health and safety of our workforce and the communities we affect is our key priority.

Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

## Duration of works

A section of Coventry Road will be closed for five days from **Monday 15 August** to **Friday 19 August**, between **8am** and **6pm**. A fully signed diversion will be in place during these times.

Temporary traffic lights will operate overnight between **15 August 2022** and **19 August 2022**, when the closure will be lifted.

Our workforce may be on-site one hour before and one hour after to set up and secure our equipment.

Some limited disruption to travel times.

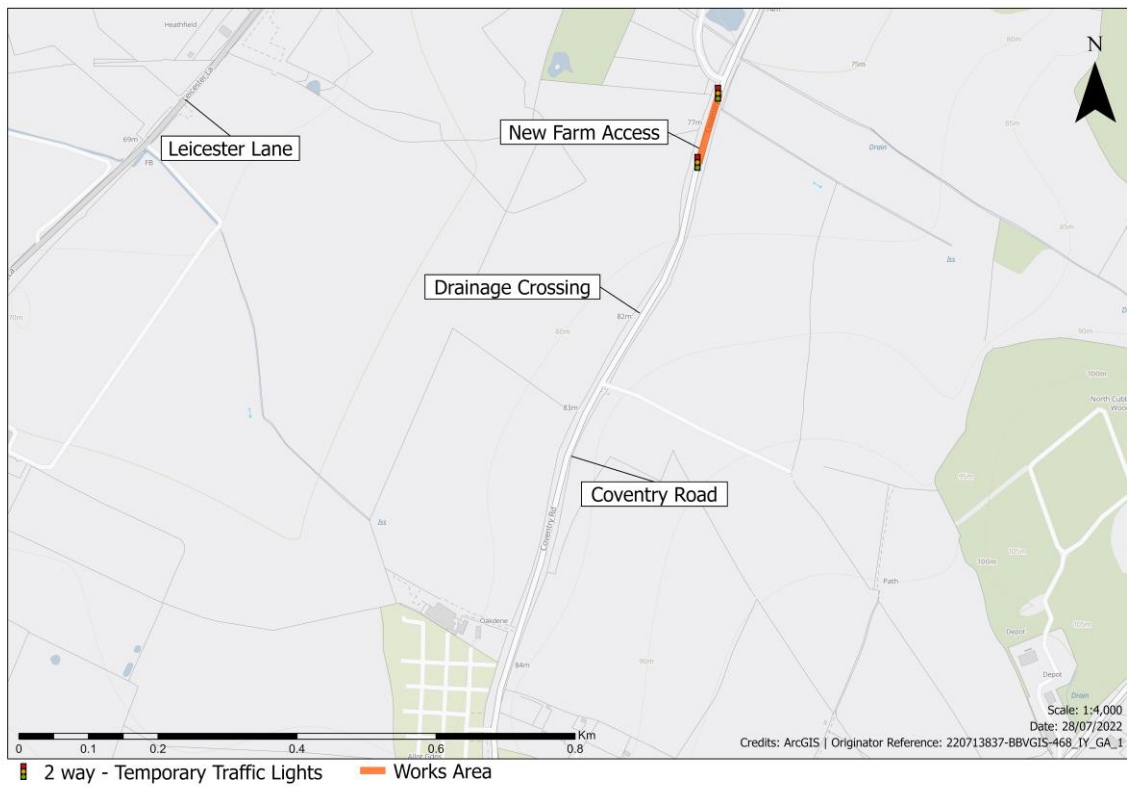
A fully signposted diversion will be in place.

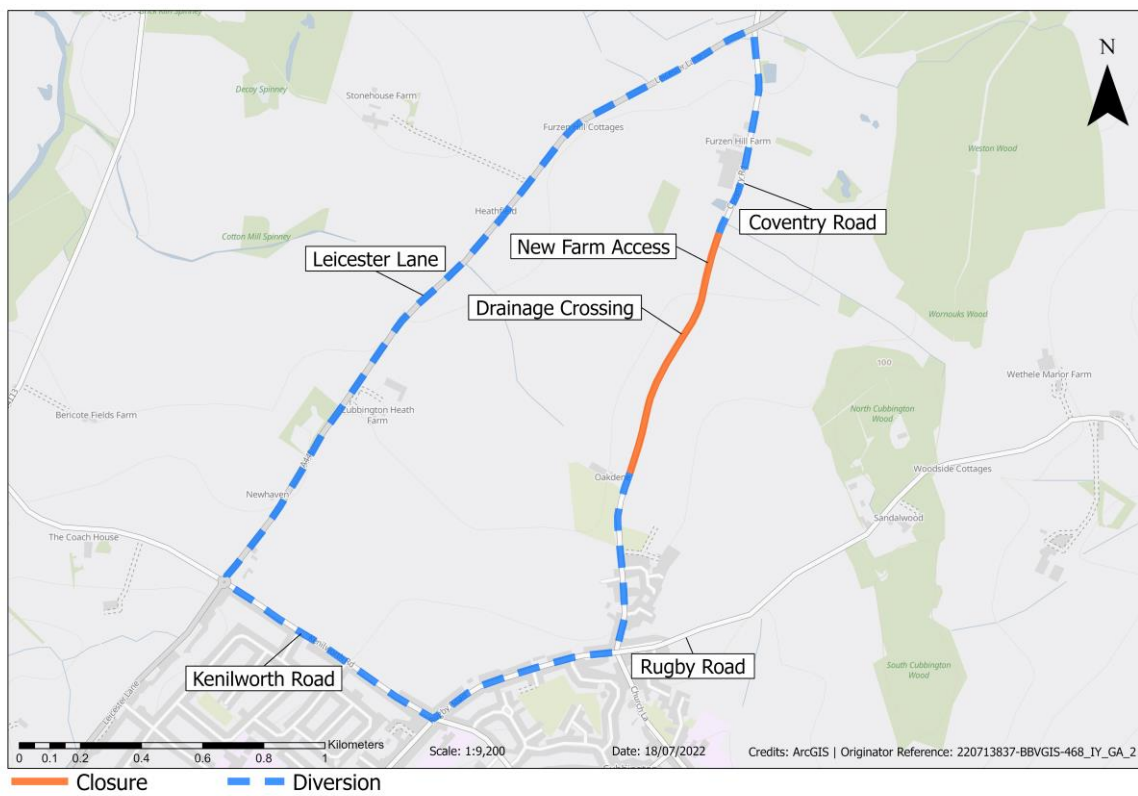
