### Notice of full road closure, Boddington Road

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. The health and safety of our workforce and the communities we work within is our priority. If you have any questions about this, please contact our Helpdesk to find out more. #### What are we doing?

As part of our Banbury Road Overbridge construction near Lower Boddington, we will be constructing a new section of highway to realign Boddington Road. Much of this highway construction will take place offline, within our construction area. The offline construction means that for most of the construction period, the existing road will remain open for highway users.

In preparation for this, we will be creating a temporary junction on Boddington Road. Once completed, the temporary junction will allow highway users to continue to use Boddington Road while we build the new sections of highway.

The construction of the temporary junction will take approximately 5 weeks during which a full closure of Boddington Road will be required. While this section of road is closed, we will also be building a new entrance junction for a nearby farm.

#### When will these works take place?

A section of Boddington Road will be fully closed, 24 hours a day, from Monday 12 September to Thursday 20 October with a signed diversion in place.

#### **Duration of works**

Works will commence Monday 12 September to Thursday 20 October 2022.

24-hours a day road closure.

#### What to expect

Varied activities with both quiet and busier periods.

24/7 Road closures and some additional traffic.

Noise from plant and equipment used for the works.

Emergency services will be allowed through the closure area with caution.

#### What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.
