



# Notice of precast delivery update, Chipping Warden

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. ## What are we doing?

In Chipping Warden, we are constructing the Chipping Warden Green Tunnel. A green tunnel, or cut-and-cover tunnel, is where a trench is excavated, tunnel structure built, then the land on top of the tunnel is restored so it blends into the landscape. The tunnel structure is built using precast segments are produced off-site.

Since July, we have successfully delivered our tunnel segments without the need for any traffic management. We will soon be receiving the delivery of a particularly wide precast tunnel segment. This segment, which includes some additional design features, will require a lane closure for the safety of road users.

We will require a southbound carriageway closure of the A361 to allow the wide load to safely pass through the narrow sections of highway near Wardington. This will be the same closure area that we required earlier in the year for our first deliveries.



## When will these works take place?

To safely deliver this abnormal load, the southbound carriageway of the A361 will be closed off-peak, 5.00am to 9.00am, on Sunday 20 November 2022. It is likely that the road will open earlier, depending on progress, and may be open before 07:00am.

If we are unable to deliver on that date, we will, as a contingency, carry out the same closure on Sunday 27 November 2022.

Construction of the tunnel is expected to be fully complete in 2024.

This delivery will take place Sunday 20 November, with an alternative, contingency date of Sunday 27 November 2022.

## What to expect

We expect to receive the delivery of a pre-cast tunnel segment.

Off-peak southbound closure of the A361 on Sunday mornings to deliver our widest precast segments.

Access for residents will be maintained.

While we build the tunnel, we will continue to receive deliveries of precast segments until 2024.

## What we will do

Minimise disruption as much as possible for the community by careful timing of deliveries.

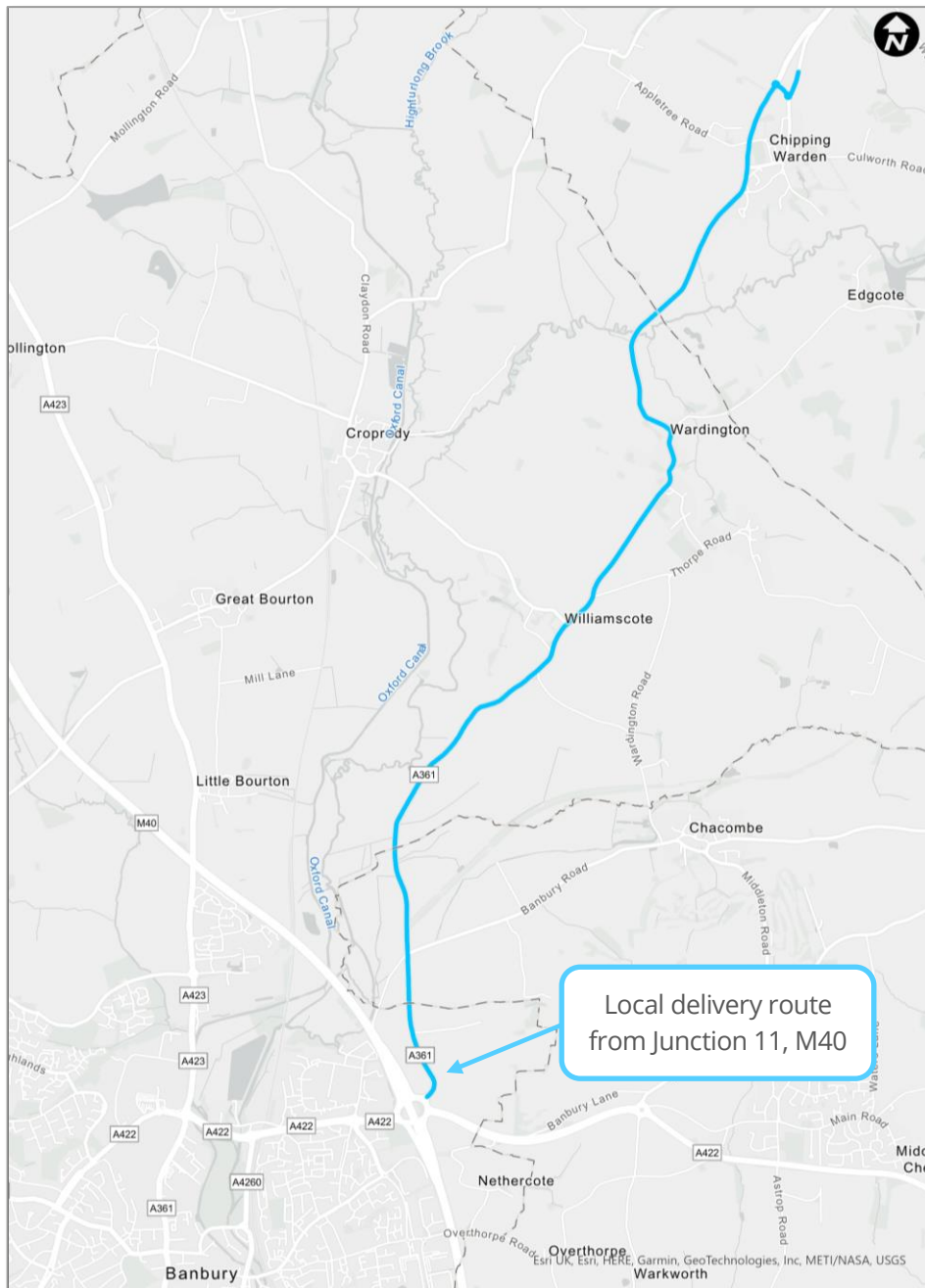
Provide updates for communities and maintain regular contact with emergency services.

## What route will be used to deliver the tunnel segments?

The tunnel segments will be delivered from Derbyshire, via the M40, where they will exit at Junction 11 for Banbury. They will then begin their journey north on the A361 travelling through Wardington Village to our Chipping Warden Compound.

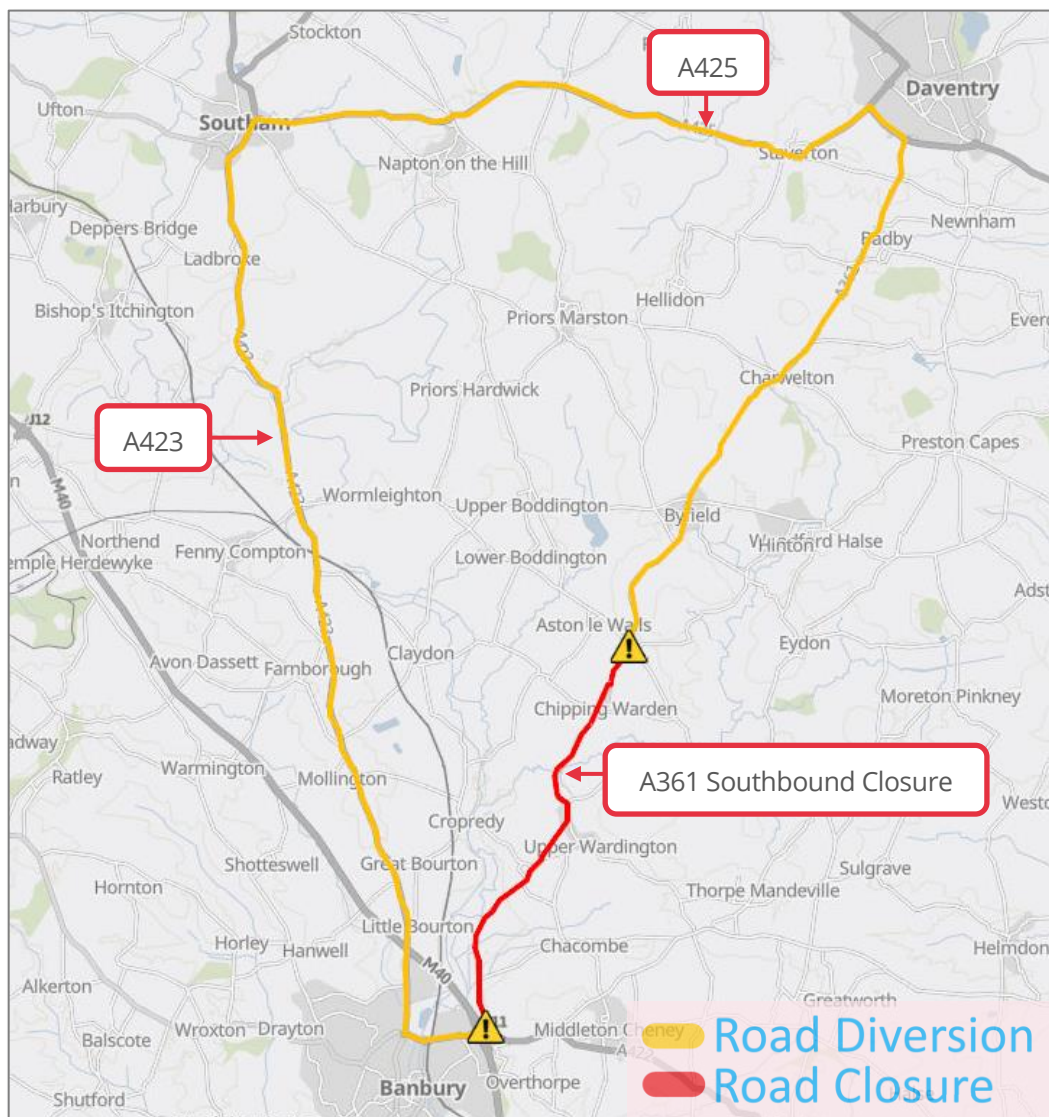
