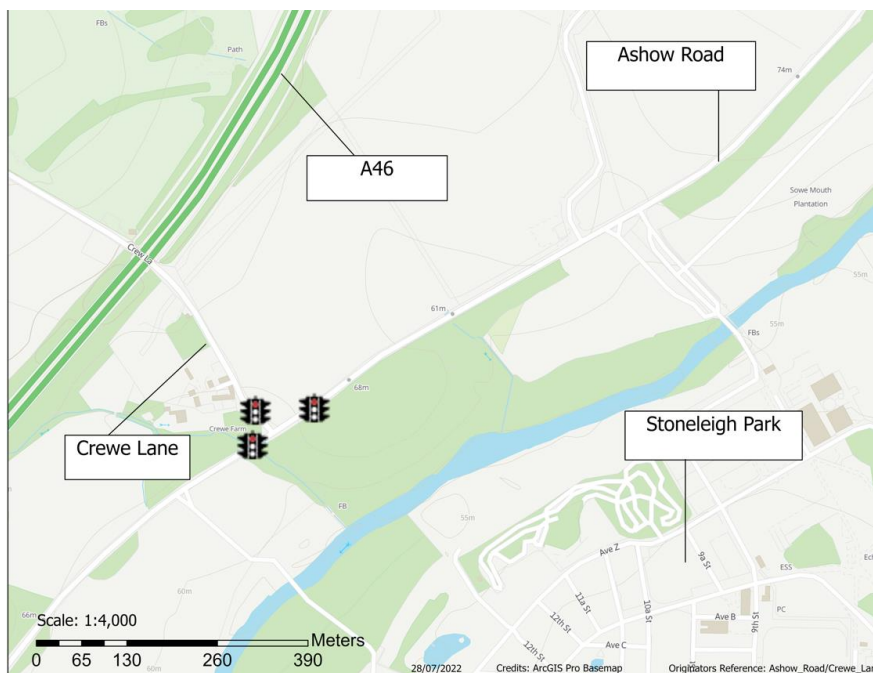
The work we will be doing

In order to complete tree surveys safely, we need to install a lane closure controlled by three-way temporary traffic lights at the junction of Ashow Road and Crewe Lane. (Please see map below).

When these works will take place

These works will take place on **Monday 15 August** between **9.30am** and **3.30pm**. The road will be reopened outside of these hours.

Our workforce maybe on site one hour before and one hour after to set up and secure our equipment.
