



Upcoming works relating to temporary re-alignment of A425 carriageway

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci is working on behalf of HS2 Ltd to build the new railway in your area.

Planned works along sections of A425 Leamington Road, Southam

Two-way temporary traffic lights are planned to be in operation along sections of A425 Leamington Road, as shown on the location plan overleaf, from Monday 5 September 2022 until Friday 25 November 2022, 24 hours a day, seven days a week.

This is to allow us to begin construction of the temporary re-alignment of a new carriageway. Works already underway relating to the temporary re-alignment of a section of the A425 Leamington Road and the construction of the green tunnel under the existing carriageway.

To minimise potential disruption to the traffic flow, the two-way temporary traffic lights will not be switched on in both locations at the same time.

The temporary traffic lights are required 24 hours of the day due to open excavations at the side of the carriageway and to conform to current safety standards.

Please note the aforementioned dates are indicative and are subject to change at short notice.

Duration of works

From Monday 5 September 2022 to Friday 25 November 2022, 24 hours, seven days a week.

What to expect

Two-way temporary traffic lights along sections of A425 Leamington Road, Southam, as shown on location plan overleaf.

These temporary traffic lights will be in operation only in one location at any one time.

We will be monitoring noise levels at all times.


