High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at www.HS2inCamden.co.uk.

North Gower Street Junction with Drummond St and Euston Road – December

We have notified you previously about BT cable installation works to take place in August and September. During December, BT will be installing new cables and jointing these cables to the existing network. These works will take place at night and will not involve noisy working. There will be no excavation. All works will take place via existing BT chambers and manholes. Lane closures will be in place at these locations with traffic still able to access these roads. There will be no disruption to existing supplies during these works.

Gordon St at junction of Endsleigh Gardens and Gower St – December

During December, BT will be installing new cables and jointing these cables to the existing network. These works will take place at night and will not involve noisy working. There will be no excavation. All works will take place via existing BT chambers and manholes. Lane closures will be in place at these locations with traffic still able to access these roads. There will be no disruption to existing supplies during these works.
