When these works will take place

These works will take place **on Monday 26 September and Tuesday 27 September.**

A closure on Crewe Lane at the junction with Ashow Road (B4115) will be in place from **9.30am to 3.30pm**.

In addition, two way temporary traffic lights will be in place on Ashow Road (B4115) at the junction with Crewe Lane from **9.30am to 3.30pm.** The road will be fully reopened outside of these hours.

A signposted diversion will be in place (please see maps overleaf for details).

Access to properties will be maintained.

Access to properties will be maintained. Some disruption to travel times. Possible noise from onsite machinery during working hours. A fully signposted diversion.


