

Notice of WPD Construction Works on A446 Lichfield Road

High Speed Two (HS2) is the new high speed railway for Britain.

What are we doing?

Western Power Distribution (WPD) need to carry out work on their assets located on Watton Lane and Gilson Road.

In order to undertake the work safely, 24-hr lane closures will be in place on the A446 Lichfield Road, these will be in two phases, phase one will be a northbound lane closure between Monday 15 August and Friday 26 August, phase 2 will be a north and southbound lane closure between Monday 28 August to Sunday 25 September. Temporary traffic lights will be in place to manage the flow of traffic. These will be in operation 24 hours each day for the duration of this work. WPDs Contractors will be working in the area Monday to Sunday 8am to 6pm. WPD maybe on site one hour before and one hour after to set up and secure their equipment.

Please note as previously advised an associated road closure will be in place at this location between midnight on Friday 26 August and 5am on Saturday 27 August. A fully signed diversion will be in place.

Duration

- Work will be undertaken between Monday 15th August to Sunday 25th September
- We will be working between 8am and 6pm seven days per week, with an hour either side of these times to set up and dismantle equipment.

What to expect

- There will be small increase in construction traffic during the works as well as a slight delay to your journey. Every endeavour will be made to keep disruption to a minimum.

What we will do

- At no time will your services be interrupted. We will complete the work as quickly as possible to avoid disruption.
