High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We will complete ground penetrating surveys along Netherstowe Lane. The surveys will help us identify the location of buried utility services, such as gas, electric or water as well as gathering information on the existing drainage systems. These surveys are non-intrusive for which we will use a machine that transmits an electromagnetic pulse into the ground. These pulses reflect off features in the ground, allowing us to collect data and to understand the depth of the buried utility services.


How we will affect you

For the safety of both our workforce and road users, we will install a one-day road closure of Netherstowe Lane. The closure will be in place on Monday 26 September from 8am until 6pm.

Access will be maintained for properties along Netherstowe Lane.
