Road, Lichfield

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To enable the construction of the new railway we will need to divert utilities, create accesses to our working areas and set up satellite compounds. We will be diverting a gas main on the Lichfield Road and completing some site clearance works.

How we will affect you

Following our recent closure, we will now install temporary traffic lights at the same location for six weeks. The traffic lights will be in place from Sunday 11 September to Sunday 23 October. These traffic lights have been extended by a week.
