High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

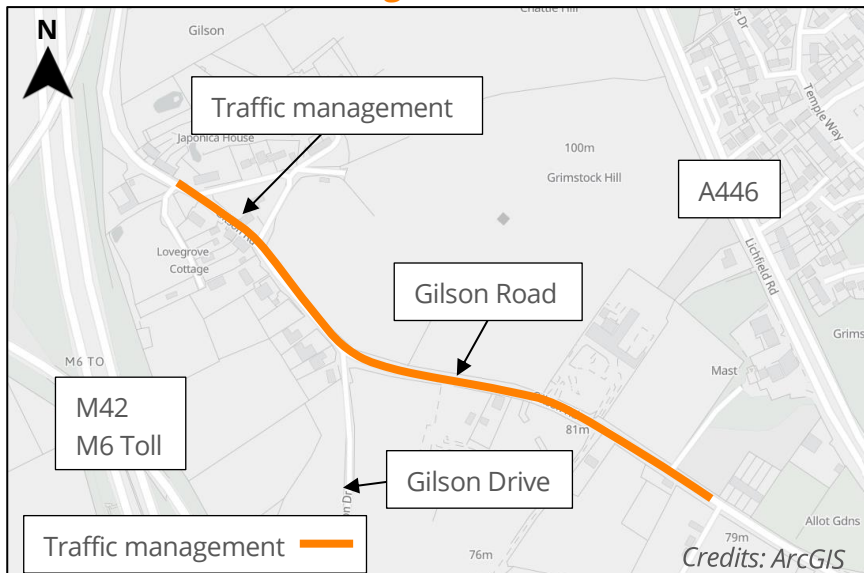
The work we are doing

To assist our preparation for the construction of the future HS2 railway, we have been carrying out surveys on Gilson Road this week to inspect the condition of existing drainage infrastructure using CCTV cameras and have installed temporary traffic measures. These measures now need to extend beyond Friday 16 September for four additional days.

We will be continuing work from Tuesday 20 September

We will continue our CCTV surveys along Gilson Road and will again operate two-way temporary traffic lights from **Tuesday 20 September until Friday 23 September**. Our working hours will be 9.30am to 3.30pm each day.
