High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will doing

We will be installing a 40mph speed limit and narrowing the lanes on the A38 northbound slip road. This is to enable us to divert utilities, which includes power, BT and Virgin Media.


## When will the work take place

The narrower lanes will be in place 24 hours a day starting in September 2022 and ending in June 2023. There may be times throughout this work that we are able to remove the traffic management for periods of time.

Throughout these works, our working hours will be 8am until 6pm.
