



# Notice of vegetation clearance in Coleshill and Water Orton

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be completing

BBV will be completing vegetation clearance works in locations across Coleshill and Water Orton throughout August and September 2022. The works will be completed for the construction of the future railway. All necessary permits will be in place prior to works being complete and where necessary, ecological surveys will be conducted prior to and during the works.

There may be times throughout the works where traffic management will be in place in order for us to carry out these works safely. In these instances, we will issue a notification and provide advance warning. We will also notify about vegetation works that may affect particular stakeholders through a specific notification.

## COVID-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

- Our workforce to be on site 1 hour before and 1 hour after, to set up and take down equipment
