High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci (BBV) is working on behalf of HS2 Ltd to build the new railway in your area.

Planned overnight works at Castle Bromwich Business Park and along A452 Chester Road

We intend to carry out ground investigation (GI) works along the Cadent Gas line located off Tameside Drive and along a section of A452 Chester Road, as shown on the map overleaf. These GI works will allow us to determine and better understand the ground conditions as well as help establish the exact locations of existing utilities.

The overnight works are scheduled to be undertaken weeknights from Monday 12 September 2022 until Friday 7 October 2022, 9pm to 6am. Our workforce maybe onsite one hour before and one hour after to set up and secure our equipment

Lane closures update

To allow us to carry out these works safely and with the least effect on communities we will need to put in place a series of both single and double lane closures along the A452 Chester Road, starting on both the northbound and southbound carriageway at the same time.

Please note these dates are indicative and are subject to change at short notice.

Duration of works

From Monday 12 September 2022 to Friday 7 October 2022, there will be no weekend work

What to expect

Lane closures along A452 Chester Road, starting on both the northbound and southbound carriageways at the same time.

These lane closures will be in operation overnight from 9pm to 6am, weeknights. Pedestrian access is unaffected.

We will install temporary fencing around our works area for the safety and security of the public and our workforce.

We will be always monitoring noise levels.

What we will do

Continue to keep public safety and that of our workforce as top priority.

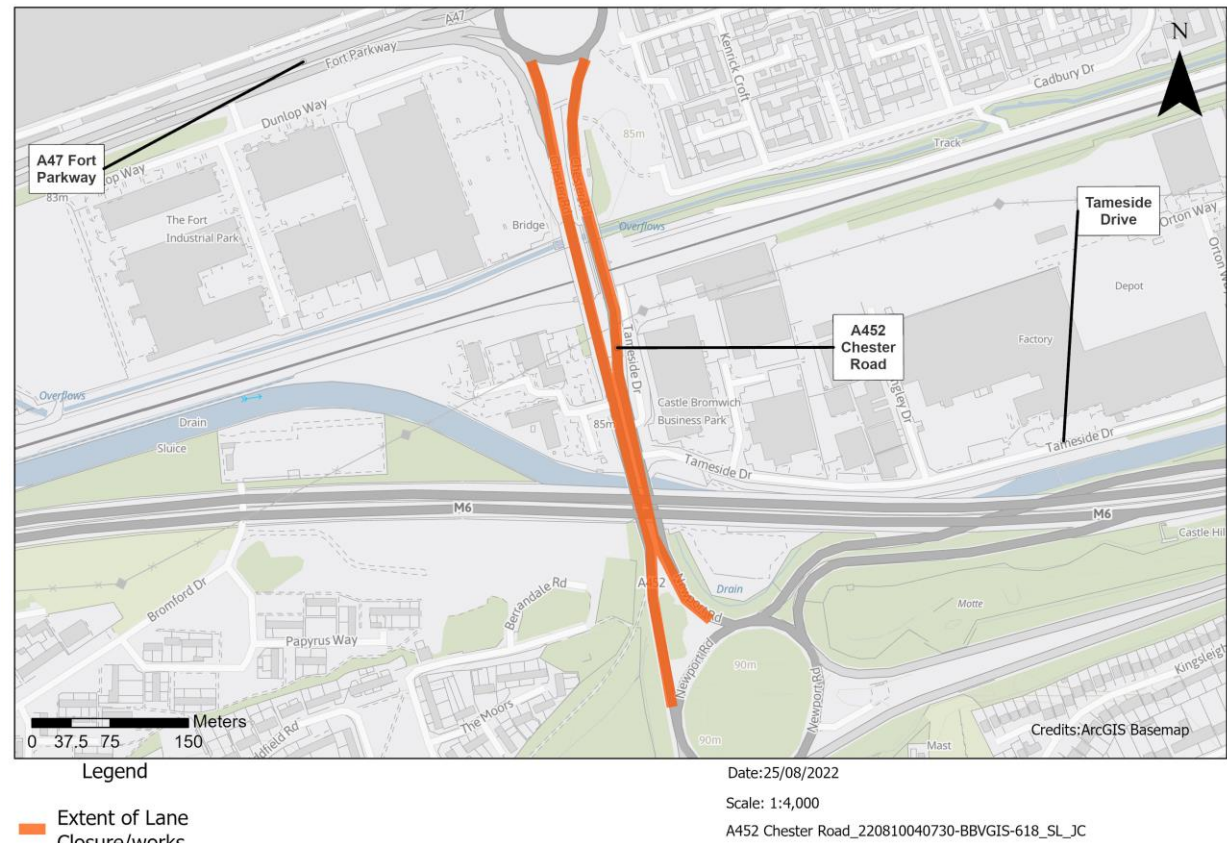
