## Extended hour working at Vehicle Holding Area

High Speed Two (HS2) is the new high speed railway for Britain.

### Extended hour working – Saturday 24 September

We previously informed you we will lift and remove the temporary cabins from the Vehicle Holding Area on Saturday 17 September. We have now rescheduled this work for Saturday 24 September.

We will use a crane to lift the cabins onto the back of lorries and remove them from site. The crane will be delivered on Friday morning and removed Saturday night.

The main welfare building will remain as it is. We don't expect these works to be noisy.
