

# Public Rights of Way (PRoW) Closure W129d/W130 and W130b, Cubbington

**Notification** 



High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

#### The work we will be doing

In order to prepare for utility diversions, we will be temporarily closing the diverted W129d, W130 and W130b footpaths, that run alongside Rugby Road near South Cubbington Woods.

The closure will take place on **weekdays from 31 August to 16 September 2022**. There will be no diversion in place. The footpaths will be closed **between 8 am and 6pm Monday to Friday**. They will be open for public use outside these times including on Saturdays and Sundays.

#### **Duration of works**


W129d W130 and W130b PRoWs will be closed on weekdays from **31 August 2022 to 16 September 2022 between 8am and 6pm**.
