



Notice of boundary wall vegetation clearance

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Vegetation clearance Drews Lane

We will be removing the remaining vegetation on Drews Lane. The work will consist of strimming and tidying the overgrowth next to our fencing.

What we will be doing?

Vegetation around and on the side of the pavement will be cleared using handheld cutters and trimmers. We will put in place barriers around our working area but the footpath will remain open. It is anticipated that there may be limited noise from the brush cutters, although this will be kept to a minimum.

We plan to carry out this work during the week commencing Monday 15 August. We expect this work to be completed in three days.

Duration of works

Work will start on 15 August 2022 and expected to last three days.

Working hours will be between 9am-5pm.

Our workforce may be on site up to 1 hour before work begins to set up the site and again afterwards to take down our work equipment.

What to expect

Vegetation will be removed from the top and side of the fencing wall and pavement which borders our site compound on Drews Lane. Vegetation will be cleared using brush cutters and handheld devices.
