High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

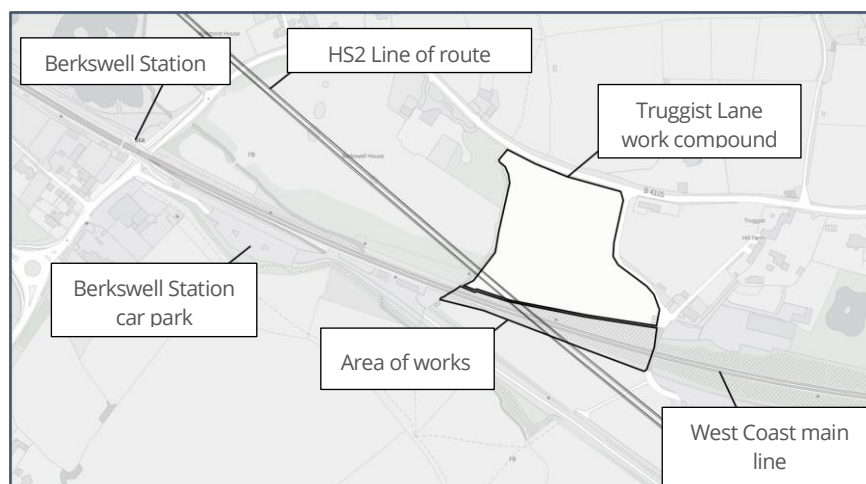
To facilitate the construction of the new HS2 Carol Green Bridge that will cross the West Coast Main Line, it is necessary to continue the works lowering the existing overhead power lines.

When will this work take place?

This work will take place overnight during railway possessions on 11 consecutive Saturday nights from 21 August to 30 October. Our working hours will be from midnight to 7am. Our workforce may be on site one hour before and one hour after to set up and secure our equipment.

The workforce will access the railway through the rear of Berkswell Station car park and Truggist Lane compound. We will keep you updated through www.hs2insolihull.co.uk.
