

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

UPDATE

To facilitate the construction of the new Carol Green Bridge for HS2 over the West Coast Main Line it is necessary to continue works to the lowering of the existing overhead power lines. This work will be done during railway possessions as required on Saturday nights from 6 November through to 18 December. The replacement of the overhead power lines will be installed during the Christmas rail closure from midnight on Christmas Eve through to 4.30am on the 27 December. Small hand tools, a track trolley and lighting towers will be used to carry out this work and should not cause any disturbance.

The workforce will access the railway through the rear of Berkswell Station car park and Truggist Lane compound. We will keep you updated through www.hs2insolihull.co.uk.
