High Speed Two (HS2) is the new high speed railway for Britain.

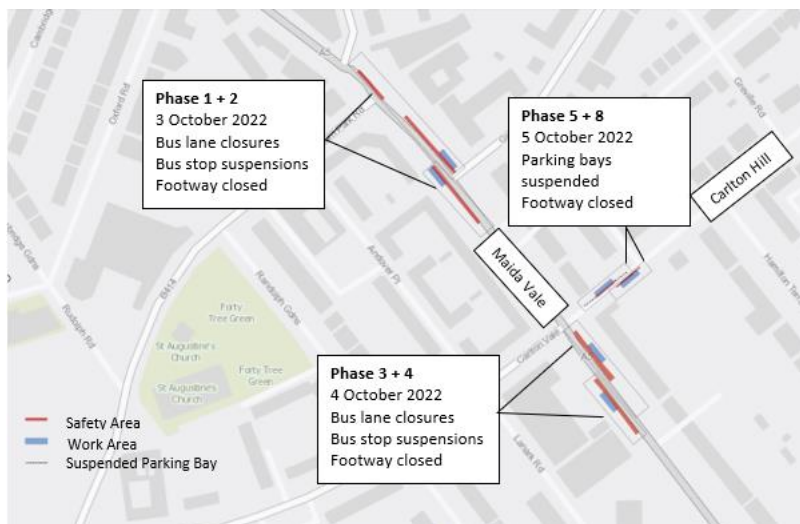
## Works planned on Maida Vale and Carlton Hill

From 3 October to 5 October 2022, we will be installing traffic management cameras on Maida Vale and Carlton Hill. The cameras will be installed onto existing lamp columns via a mobile platform from either a bus lane or parking bay (location dependent).

These cameras will be in place for the duration of the HS2 works to monitor lorry movements to and from HS2 sites.

## How this may affect you

Temporary changes will be in place on Maida Vale and Carlton Hill during the camera installation.
