High Speed Two (HS2) is the new high speed railway for Britain.

# Rail weighbridge testing – 9, 10 and 11 September 2022

We are continuing to receive excavated materials to Willesden Euroterminal site by road from other HS2 sites in the area for removal by rail. As part of our ongoing operation of the rail terminal we will be carrying out testing of a rail weighbridge during September.

We will be carrying out tests on the weighbridge between 8am and 6pm on 9, 10 and 11 September. The tests will involve pushing rail wagons over the weighbridge to test that it is operating correctly. The weighbridge tests are not expected to be disruptive to residents, however you may notice some rail wagon movements taking place to and from the Willesden Euroterminal site.

The map below shows the approximate location of the rail weighbridge.
