# Notice of relocation of dust monitor on Stephenson Street

High Speed Two (HS2) is the new high speed railway for Britain.

### **Relocation of dust monitor on Stephenson Street**

Following a review of monitors in the area, we will be moving the monitor located on the lamppost outside 55 Stephenson Street to its new location on the lamppost near 67 Stephenson Street and closer to the rail tracks.

The picture below shows what the monitor may look like. It will transmit data using the existing phone network.



You will notice a small team of operatives during the relocation and installation of the monitor. works will last approximately 2 hours. We do not anticipate these work to be disruptive to the local community.

### **Duration of works**

We plan to move the monitor during early October 2022

The exact date for moving the monitor is subject to availability of a specialist electrician
