



# Notice of road closure – East Way, Bickenhill Update

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working on behalf of HS2 Ltd to build the new high-speed railway in your area.

## What work will we be completing

Due to the adverse weather the last two beams are going to be late for delivery and we require to extend the works to the Thursday 17 November.

We will be taking delivery of the pre-cast concrete beams which form the bridge deck for the new East Way Bridge which allows HS2 to pass under the A45. The delivery of the beams is an Abnormal Load and will have a police escort. To off load the beams for the bridge we will need to close the East Way, Bickenhill for a short period during the night.

## When the work will take place

The works will take place on consecutive Thursday nights from the 20 October through to the 17 November 2022.

To complete our works in a safe environment, we will be closing the East Way, Bickenhill from midnight to 5am.

If the work is completed early, we will remove the closure.

## HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines

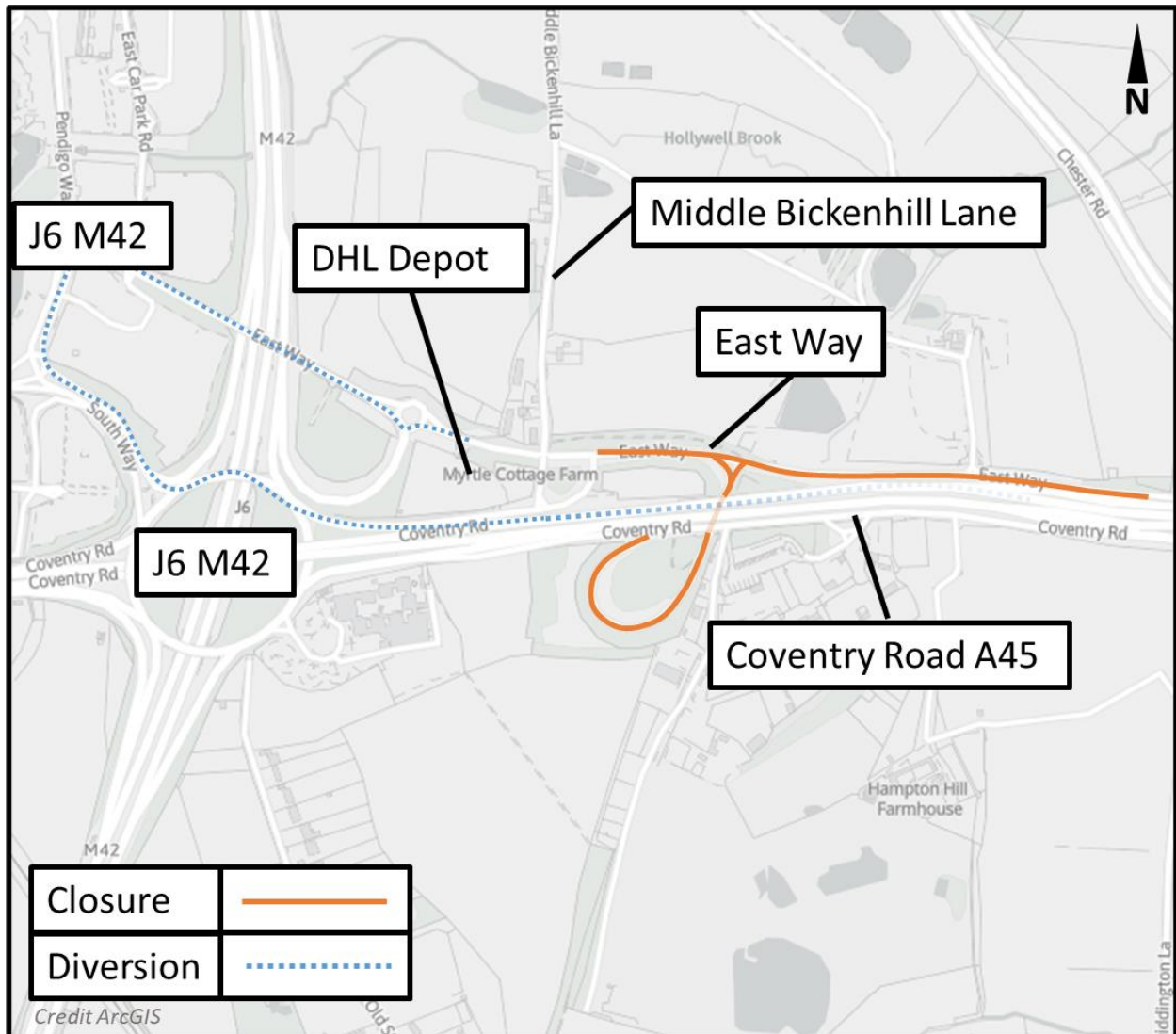
